

# 10 Places in Peril

## 2023 Nomination Form

Do you know of a special irreplaceable historic building or site that is in danger of being lost? If so, this is your opportunity to help save it! The Georgia Trust's *Places in Peril* program identifies historic sites facing real threats like demolition, neglect, lack of maintenance and inappropriate development. Bring attention to Georgia's threatened resources by making a nomination to the 2023 *Places in Peril* list.

### Nomination Requirements:

- **Form.** Completed nomination form. Please type or print clearly in pen. Emailed nominations are encouraged.
- **Photographs.** A minimum of 10 and maximum of 15 digital images. Individual image files should be JPG format and at least 300 dpi. Do not submit images in a Word document or PDF file. Please provide a list of images with short captions and credits for each image submitted. These images need to give the *Places in Peril* Committee an accurate impression of the property; well-lit subjects and a range of views that clearly depict the condition or reasons why the site is in peril are extremely helpful. Historic images are encouraged if available. Images are non-returnable. Submission of images by nominator constitutes a release-agreement allowing The Georgia Trust to use images for publication in newsletters, press announcements, etc. Emailed nominations are encouraged; large photo files can be shared through Dropbox, Google Drive or any file sharing software.
